

THIS FIRST AMENDMENT TO THE DECLARATION OF COVENANTS AND RESTRICTIONS FOR THE REFUGE AT WHITEHALL AND PROVISIONS FOR AND BY-LAWS OF THE REFUGE AT WHITEHALL OWNERS ASSOCIATION, INC. (this "First Amendment") is made this _3_ day of May, 2007, by Refuge at Whitehall, LLC, a South Carolina limited liability company (the "Declarant").

WITNESSETH

WHEREAS, the Declarant executed that certain Declaration of Covenants and Restrictions for the Refuge at Whitehall and Provisions for and By-Laws of the Refuge at Whitehall Owners Association, Inc. (the "Declaration"), which was recorded in the RMC Office for Dorchester County, South Carolina on December 5, 2003, in Book 3921, Page 053, restricting certain real property located in the City of North Charleston, County of Dorchester, State of South Carolina known generally as "Refuge at Whitehall" and being more particularly described in Exhibit "A" to the Declaration (the "Property"); and

WHEREAS, pursuant to the terms of Article XI, Section 11.02(c) of the Declaration, the Declarant alone, prior to the Turnover Date, may amend the Declaration, at any time to correct scrivener's errors, by written instrument duly recorded in the RMC Office for Dorchester County, without having to seek or gain the prior consent or approval of any Owner of any Lot; and,

WHEREAS, the Declarant desires to amend the Declaration to correct a scrivener's error in Article IV, Section 4.02(b)(iii) of the Declaration.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, pursuant to the powers reserved to the Declarant under the Declaration, the Declarant hereby amends the Declaration as follows:

1. Article IV, Section 4.02(b)(iii) is deleted in its entirety, to have no further force and effect, and replaced with the following language:

"Class C Members" shall be the Owners of Lots 30-38, 40 and 41. Class C Members of the Association shall be treated in all respects as either Members of Class A or Class B, except that by virtue of their membership in Class B they

shall collectively be responsible for all expenses related to the repair, maintenance and upkeep of the "NEW 20' COMMON ACCESS EASEMENT FOR LOTS 30-38, 40-41" as shown on a Plat by Connor Engineering, Inc. entitled "A FINAL SUBDIVISION PLAT OF THE REFUGE AT WHITEHALL OWNED BY THE REFUGE AT WHITEHALL, LLC. LOCATED IN THE CITY OF NORTH CHARLESTON DORCHESTER COUNTY SOUTH CAROLINA", said Plat dated October 17, 2003, and recorded December 1, 2003 in the RMC Office for Dorchester County, South Carolina in Plat Cabinet K, at Page 83, Instrument Numbers 131-132.

2. Except as set forth in this First Amendment, the Declaration shall remain in full force and effect.
